## 2019 Florida Elder Justice Conference: Speaker Bios

#### **Dorene Barker**

Dorene Barker earned her Juris Doctorate at Florida State University, College of Law. After graduation she volunteered as an Emeritus Attorney for seniors where she received numerous Community Service Awards including recognition by Governor Chiles for pro bona legal representation. She was first hired by Department of Revenue as a Senior Staff Attorney. She received the coveted Silver Pickle Award for superior and conscientious effort in problem solving and solution creation.

Dorene was invited to apply to Florida Legal Services (FLS) where she was hired as a legislative advocate and within a few years became the Legislative Director where she remained for nearly 20 years. Ms. Barker managed lobbying and advocacy activities with the Florida Legislature on behalf of low-income clients. Dorene was honored as first runner-up for Stephen M. Goldstein Award for Excellence by the Florida Bar Foundation.

During her time at FLS, Ms. Barker also joined the Florida State University, College of Law as an Adjunct Professor where she taught 2<sup>nd</sup> and 3<sup>rd</sup> year law students. After a brief "retirement" from FLS, Ms. Barker joined AARP as an Associate State Director of Advocacy where she continues to lobby on behalf of vulnerable adults.

### **Edwin Boyer**

Edwin M. Boyer is a Florida Bar Board Certified Elder Law Attorney and a member of the law firm of Boyer & Boyer; P.A. Mr. Boyer has practiced law in Sarasota, Florida, since 1978. He received his Law degree from Stetson University College of Law in 1978, and he holds a Bachelors, Masters and Educational Specialist Degree from the University of South Florida.

Mr. Boyer was also the recipient of the Florida Bar President's Pro-Bono Service Award for the 12<sup>th</sup> Judicial Circuit (1994) Stetson University College of Law Wm. The Office coordinates and manages a federal response to elder abuse, including supporting and chairing the Elder Justice Coordinating Council and coordinating innovation and demonstration activities, in order to provide a coordinated and seamless response for helping to transform adult victims of abuse into survivors and to prevent abuse before it happens.

The Office supports legal assistance programs for older Americans in all states through technical assistance, a grant program to improve the delivery of legal aid to older Americans with economic or social need, and sponsorship of the National Center for Law and Elder Rights, a national resource center. The Office promotes elder economic security through pension counseling programs funded through the Older Americans Act and programs to increase financial literacy among elders.

Previously Hilary was with the Department of Health and Human Services' Centers for Medicare and Medicaid Services (CMS). Prior to joining the government, Hilary was involved nationally and at the state level with benefits access for elder and legal assistance to older Americans. She was a legal assistance attorney and manager in older Americans offices for many years and has taught elder law and health law at a number of law schools. She is a past Chair of the Connecticut Bar Elder Law Section.

## Mary Ann David

Mary Ann David was introduced to the nonprofit world relatively late in her career and she's never looked back. After a short stint volunteering on a legal advice line here at Legal Services, Mary Ann was asked to put her CPA and legal skills to work temporarily managing our Low Income Taxpayer Clinic. It was a perfect match! Now Mary Ann advocates on behalf of low income taxpayers, helps resolve their disputes with the IRS, such as recovering their refunds, and educates them about their tax rights and responsibilities.

## Katy DeBriere

Katy DeBriere is managing attorney of the Northeast Florida Medical Legal Partnership (NFMLP) and Legal Director of the Florida Health Justice Project. She has experience both in identifying and addressing systemic issues through impact litigation and in representing a large number of individual clients with Medicaid eligibility and service issues.

Katy began her legal career in 2008 as an Equal Justice Works fellow. Her two year fellowship generated several state court of appeals successes, two 42 U.S.C. 1983 suits, and culminated in a successful facial constitutional challenge to a state statutory scheme for the commitment of person with developmental disabilities. Within a year of being hired to direct the NFMLP, Katy secured significant funding for the partnership – the first time external funding has been obtained in the project's 12-year history. Katy has taken a lead role in developing statewide medical legal partnership (MLP) network and recently received funding to provide a series

of webinars on public benefits programs available to low income Floridians, including the Medicaid program. She received her J.D. from the University of Florida.

## Nicole M. Del Rio

Nicole M. Del Rio is a Staff Attorney with the Senior Advocacy Unit at Bay Area Legal Services, Inc. Nicole primarily practices landlord/tenant and family law for clients over 60. Nicole graduated with a Bachelor's degree in Legal Studies from the University of Central Florida and attended Florida International University's College of Law, where she earned her Juris Doctor.

## Lynn Drysdale

Lynn Drysdale is a consumer protection attorney who has been with Jacksonville Area Legal Aid, Inc. for over 30 years. She engages in litigation and legislative advocacy relating to homeownership, debt collection, payday loans, motor vehicle sales and financing, student loans and other consumer-related issues. She was Cochairman of the Board of the National Association of Consumer Advocates and Chairman of the Florida Bar Consumer Protection Law Committee and has been a contributing writer for the National Consumer Law Center practice manuals and coauthored The Two-Tiered Consumer Financial Services Marketplace: The Fringe Banking System and its Challenge to Current Thinking About The Role of Usury Laws in Today's Society, a law review article for the South Carolina Law Review. She was vice-chair and rising chair of the Consumer Advisory Board of the Consumer Financial Protection Bureau until fired by the present administration. She was also chair of its Small Business Lending Markets and Mortgage subcommittee. She is also an adjunct consumer law professor at the University of Florida, College of Law.

### **Roberta Flowers**

Roberta Flowers is a professor of law at Stetson University College of Law. Within the Elder Law LL.M. program, Professor Flowers teaches Ethics in an Elder Law Practice. She also teaches Evidence, Criminal Procedure, and Professional Responsibility. While at Stetson, Professor Flowers has successfully coached trial teams, arbitration teams and moot court teams to national championships. She has served as the director of the Center for Excellence in Advocacy and as the William Reece Smith Jr. Distinguished Professor in Professionalism. During her time at Stetson, Professor Flowers has received the university-level Excellence in Teaching Award, Most Inspirational Teacher Award from the Student Bar Association, and an award from the Student Bar Association for supporting student life. She also has received the university-level Homer and Dolly Hand Award for Excellence in Scholarship, the Dean's Award for Extraordinary Service, and been awarded the Distinguished Service Award four times. In 2005, the Florida Supreme Court awarded Professor Flowers the Faculty Professionalism Award.

Professor Flowers has lectured worldwide on the topic of ethics. She won a Telly Award for Excellence in Educational Films for having produced a series of educational videos on the ethical issues faced by prosecuting attorneys. Along with Professor Rebecca Morgan, she created a video series used to train and educate attorneys nationwide on the ethical dilemmas faced by elder law attorneys. The Florida Supreme Court awarded Professor Morgan and Professor Flowers the Florida Supreme Court Professionalism Award for their video productions. Additionally, with Professor Morgan, Professor Flowers designed the nation's first "elder friendly courtroom," which serves as model for courtrooms of the future.

Before arriving at Stetson, Professor Flowers worked as a prosecutor in both the state and federal system. She began her career in 1984 as a deputy district attorney for the 18th Judicial District of Colorado, where she served as a trial attorney in the criminal division. In 1989, she was appointed assistant U.S. attorney for the Southern District of Florida, where she served in the Appellate Division, the Major Crimes Unit and the Public Corruption Unit.

Professor Flowers graduated *magna cum laude* from Baylor University in 1979 with a bachelor's degree in psychology. She received her J.D. from the University of Colorado in 1984, where she was selected to be a member of the Order of the Coif. Professor Flowers' research interests center on the issues of ethics and professionalism. Professor Flowers' articles have appeared in such journals as the Fordham Law Review, the Boston College Law Review, Missouri Law Review, the Nebraska Law Review, the Ohio State Journal of Criminal Law, Hastings Constitutional Law Quarterly, the Stetson Law Review, and the NAELA Journal.

Professor Flowers is active in several professional associations. She has served on numerous committees of The Florida Bar, including the Professional Ethics Committee, the Evidence Committee, and the Standing Committee on Professionalism. She is currently the chair of the Professionalism Sub-Committee of the Litigation Section's Ethics and Professionalism Committee of the American Bar Association.

## Wynn Gerhard

Wynn Gerhard has been practicing Elder Law at Greater Boston Legal Services for over 30 years. As a nationally recognized leader in elder law and guardianship reform, she has spoken at the National Guardianship Association conferences, the American Society on Aging, and the ABA Commission on Law and Aging. She has also been inducted into the National Association of Legal Services Developers Elder Rights Hall of Fame.

Wynn was recently appointed to serve on the Special Legislative Commission on Elder Economic Security, for which she co-chairs the Housing Work Group. This Special Commission is charged with making recommendations to the legislature to improve the economic well-being of seniors in Massachusetts. Miriam's work focuses on expanding access to health care for vulnerable populations, and she has been lead counsel or co-counsel on multiple federal court cases resulting in statewide systemic relief for Medicaid beneficiaries. These successful outcomes are the result of highly collaborative work with national experts, pro bono attorneys and Florida legal aid lawyers eager to engage in impact advocacy. # Dominic C. "Donny" MacKenzie:

Donny MacKenzie is the Executive Director of the Florida Bar Foundation. Appointed by the Foundation's board of directors in 2018, Donny serves as the chief executive officer of the Foundation. In conjunction with the board of directors, the executive director sets a vision for organizational development, oversees systems, structures and internal policies, and leads the Foundation in its mission of providing strategic support and funding for civil legal services. In his role as executive director, Donny is the chief spokesperson for the Foundation, representing the Foundation to internal and external audiences, conveying the vision of the Foundation and motivating staff and all stakeholders to work collaboratively to achieve the strategic goals of the Foundation.

Donny obtained his bachelor's degree in communications from Florida State University and earned his law degree from the Florida State University College of Law. After practicing in Fort Lauderdale from 1987 to 1993, Donny moved back to his hometown of Jacksonville and joined Holland & Knight in 1993. His practice specialized in medical and professional malpractice defense, health care litigation, product liability, construction litigation and personal injury.

Donny has shown a devotion to providing civil legal aid throughout his career, being Holland & Knight's pro bono partner for Jacksonville and serving as a member of the Florida Commission on Access to Civil Justice since 2014 and co-founder of the Campaign to Maintain Justice in Jacksonville in 1995.

He was recognized by The Florida Bar with the President's Pro Bono Award for the Fourth Judicial Circuit in 1998. Holland & Knight honored him as its Pro Bono MVP Partner in 2006, and he has been recognized by the firm as a Pro Bono All Star since 2005. He was recently recognized as the 2016 recipient of the Robert J. Beckham Equal Justice Award from Jacksonville Area Legal Aid (JALA) and was also appointed as a board member for the Florida Justice Technology Center.

After serving on the Foundation's Board of Directors for eight years, Donny took office as its president in 2015-16. He has served on the Foundation's Legal Assistance for the Poor, Law Student Assistance, Grants, Interest on Trust Account Operations, Development, Strategic Reset, and Executive Committees.

Donny has served on various state and local bar committees, some of which include the Florida Rules of Civil Procedure Committee (chair 2002-2003), the Florida Code and Rules of Evidence Committee (chair 2008-2009), the Florida Rules of Judicial Administration Committee, Professionalism Committee, Florida Pro Bono Legal Services Committee (chair, Rules subcommittee), Florida Bar Grievance Committee for the Fourth Judicial Circuit "B" (chair 2014), and JALA's Guardian Ad Litem and Pro Bono Committees. ## **Catherine Peek McEwen**

Catherine Peek McEwen is a United States Bankruptcy Judge for the Middle District of Florida (appointed August, 2005). She is also an adjunct professor at the Western Michigan University Cooley Law School. Prior to becoming a judge, she was in private practice, concentrating on commercial litigation with an emphasis on representing parties in bankruptcy cases.

Judge McEwen was graduated from Stetson University College of Law *cum laude* in 1982 and received a Bachelor of Arts degree from the University of South Florida (Political Science) in 1979 after obtaining an Associate of Arts degree from Hillsborough Community College in 1975.

She was elected into the American Law Institute in 2012. Among her other honors are the Stetson University College of Law Distinguished Alumnus Award (2007), Hillsborough County Bar Association Jimmy Kynes Pro Bono Service Award (2008), the Stetson University College of Law J. Ben Watkins Award (2009), the Florida Association for Women Lawyers Leaders in the Law inaugural class designation (2010), the Tampa Bay Hispanic Bar Association's Luis "Tony" Cabassa Award (2012), the Hillsborough Community College Outstanding Alumnus Award (2012), the George Edgecomb Bar Association's Delano S. Stewart Diversity Award (2015), the inaugural Florida Supreme Court Chief Justice's Distinguished Federal Judicial Service Award (2016), the Stetson Lawyers Alumni Association Ben C. Willard Award (2016), the University of South Florida Distinguished Alumna Award (2016), and the Bay Area Legal Services, Inc. Judge Don Castor Justice Award (2016). In 2017, she was appointed by Chief Justice John G. Roberts, Jr. to be the non-voting

bankruptcy judge Observer at the Judicial Conference of the United States for a twoyear term.

Prior to becoming a lawyer, she was a sportswriter from 1975-1979 for the *Tampa Tribune* and the *Tampa Times*. In her spare time, she enjoys managing or coaching Little League developmental softball teams (ages 6-8), teaching Sunday School to 6th graders, singing karaoke, watching professional and major college sporting events, and sometimes playing duplicate bridge.

## Shannon M. Miller

Shannon M. Miller is a Florida Bar board certified attorney specializing in Elder Law, in Gainesville, Florida. Shannon served as a drafting member of the Financial Exploitation of Vulnerable Adults Workgroup, led by now Florida State Senator, Kathleen Passidomo. The drafted legislation was passed in the 2014 legislative session, and created groundbreaking tools for prosecutors and civil practitioners to crack down on the exploitation of our most vulnerable citizens. Shannon also assisted in drafting the Guardianship legislation further protecting seniors in the 2015 legislative session. Shannon, as part of the Elder Law Section, created new legislation relating to injunctions for exploitation and freezing stolen assets, again with the leadership of Senator Passidomo and Representative Colleen Burton in 2018 and has been instrumental in rolling out its practical implementation in the community.

Shannon has served as President of The Academy of Florida Elder Law Attorneys, serves on the Florida Joint Public Policy Task Force for the Elderly and Disabled, serves as Co-chairperson of the Legislative Committee of the Elder Law Section and a founding member of the North Central Florida Senior Advocacy Network, which is comprised of dedicated stakeholders determined to work together to stop exploitation in North Central Florida. She was Elder Law Section Member of the Year for 2016-2017 for her dedicated advocacy to protecting the rights of seniors and the Disabled.

## Ashley Moody

Florida Attorney General Ashley Moody, a fifth generation Floridian, was born and raised in Plant City, Florida. She attended the University of Florida where she earned her bachelors and masters degrees in accounting and Juris Doctorate. She later attended Stetson University College of Law earning a masters of law in international law. In 2018, she was elected the 38<sup>th</sup> Attorney General of Florida.

General Moody joined the United States Attorney's Office prosecuting drug, firearm, and fraud offenses. While a federal prosecutor, Ashley was commended by the DEA for prosecutorial excellence and outstanding initiative in drug law enforcement. She was also recognized by the Florida Department of Law Enforcement for her lead of "Operation Round-Up," a targeted prosecution of violent and repeat offenders.

In 2006, at the age of 31, General Moody became the youngest judge in Florida when she was elected Circuit Court Judge of the 13<sup>th</sup> Judicial Circuit in Hillsborough County. As a judge, she founded the Attorney Ad Litem program recruiting volunteer attorneys to stand in the place of parents who did not appear in court with their children. She also developed a mentoring program for at-risk children within the juvenile delinquency system.

## **Patrice Paldino**

Patrice Paldino, Esq., M.S. Ed., currently serves as the Executive Director of Coast to Coast Legal Aid of South Florida (CCLA).

Prior to joining CCLA, Ms. Paldino worked for Legal Aid Service of Broward County, Inc. for 10 years as the Director of Housing Rights Programs. The success of the HIV program has introduced Ms. Paldino as a national expert in the Medical-Legal Partnership (MLP) model for the delivery of legal services. Because of her understanding of how poverty and housing injustice intersects with other social factors, she has also spoken at summits on topics such as Housing Rights for Seniors Aging with HIV; Housing Rights for Domestic Violence survivors; and Fair Housing issues, such as the right to reasonable accommodations in housing and the right to live free from racial, sexual or gender discrimination, at events funded by the US Department of Housing and Urban Development (HUD).

#### Arthur Rosenberg

Arthur Rosenberg has been an attorney on behalf of low income persons for 40 years, and has practiced law in Florida on their behalf since 1992. Before moving back to Florida in 1992, he practiced disability law at Southeastern Pennsylvania Legal Services for the Deaf, then served as Deputy Director of the New Jersey Department of the Public Advocate's Division of Mental Health Advocacy, and as Senior Attorney for Disability Rights California. In 1992, Arthur began the Homeless Legal Unit at Legal Services of Greater Miami with a grant from the Florida Bar Foundation, providing legal assistance and advocacy for homeless persons throughout Miami Dade County. Among other issues, Arthur's work at FLS included: securing passage of and assuring continued compliance with the Florida Labor Pool Act, a model state law to address the exploitive practices of day labor pools; expanding unemployment insurance eligibility for low wage and part time workers and improve access to benefits; helping secure the passage of the Florida Title Loan Act and the Payday Loan Act in the Florida Legislature, enhancing legislative limitations on predatory lending practices; co-founder of the Community Coalition of a Living Wage, which advocated for living wages and worker justice for low wage workers, resulting in the passage of living wage ordinances in Miami-Dade County(1999,) City of Miami Beach (2001,) Broward County (2002,) and City of Miami (2006;) co-counsel in Pottinger v. City of Miami, a landmark federal class action lawsuit establishing civil rights of homeless persons, preventing their arrest by city police for being homeless, and establishing guidelines and limits on police interaction with persons living on the streets and in public parks. Arthur was appointed to the Governor's Council on Homelessness in 2008 by Gov. Crist, and after reappointment by Gov. Scott, served until 2013. He has also served as President of the Board of Directors of the Miami Coalition for the

Homeless, and was a long time member of the Board of the Florida Coalition for the Homeless. He is now serving as Chair of the Miami Dade County Living Wage Commission.
