#### **Statewide Senior Legal Helpline**



The Florida Senior Legal Helpline provides legal advice and brief services over the telephone to financially eligible Floridians 60 years of age and older about Medicaid issues and other civil legal problems. We provide advice about the Medicaid Long-Term Care waiver including the income and asset limits and the application process. Although we do not prepare trusts or legal documents like wills or deeds, we can give general advice to those with excess assets and income. For those enrolled in the waiver, we can advise how to request additional services and how to appeal if those requests are denied. We can sometimes facilitate communication between applicants and agencies to help applicants obtain or provide information which will advance their own advocacy. If you need legal assistance over and above the telephone services we provide, or you need an attorney to represent you, we will inform you about other programs in your community which may be able to help.
